

**REGULAR SESSION MEETING Dec 1, 2015**  
 Council met in regular session on Tuesday,  
 December 1, 2015, @ 7:00 p.m. in the Council Chambers.

**OPENING:** President C. Ewing opened the meeting with a salute to the flag. President C. Ewing took roll call for attendance and reviewed the reports, announcements and correspondence with Council.

**MINUTES:** Motion by J. Sweet, seconded by McLallen to approve the minutes from the November 3rd Regular session. The motion was carried unanimously.

- Cris Furey, VP Financial Services, Financial Advisor and Sherry Greggs, Stoneboro Branch Manager with Mercer County State Bank. A discussion was held about the police pension fund and the non-uniform pension fund.

#### **Mayor Report**

- Mayor Everall told council that he received the police report from Chief Valimont. Mayor stated that he and Chief Valimont are addressing a residents complaint and also discussed residents parking longer than the allotted time on Lake Street in front of the Borough building and Mercer County State Bank.

#### **COMMITTEE REPORTS**

##### WATER & SEWER

- A discussion was held about the opportunity to lower the rate of the sewer loan at Mercer County State Bank by 1%. A motion was made by J. Sweet seconded by McLallen to take the reduction of 1% on the sewer loan. Motion passed by unanimous vote.

#### FACILITIES, GROUNDS & SAFETY

##### FINANCE

- McLallen made a motion, seconded by Patterson to approve paying bills dated 11/13 & 11/23 as amended. The motion carried unanimously.
- A motion was made by McLallen to approve the budget, seconded by J. Sweet. The motion carried by unanimous vote.
- A motion was made by Moeller, seconded by J. Sweet to provide a letter of intent to purchase a 2015 F150 from Day Fleet Sales for \$30,247.00. Purchase to be completed January of 2016.

PERSONNEL

- A motion was made by Ewing, seconded by Patterson to continue the employment of Tyler Valimont as the Chief of the Borough of Stoneboro and increasing his hourly wage to \$16.00 per hour. The motion carried by unanimous vote.
- A motion was made by McLallen, seconded by Patterson to provide Chief Valimont benefits including medical, dental, and vision. The motion carried by unanimous vote.
- A motion was made by Patterson, seconded by J. Sweet to advertise for an as needed part time maintenance person. The motion carried by unanimous vote.


**New Business**
