**COMMITTEE REPORTS**


Water and Sewer

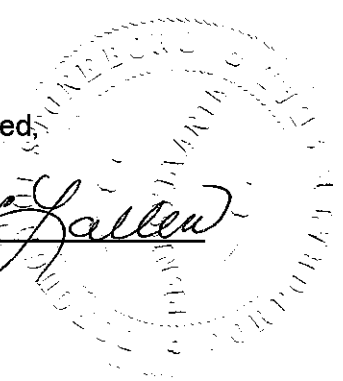
- Council discussed going to Mercer County State Bank for a bridge loan for the Municipal Water System Improvement Project.



### **COMMITTEE REPORTS**

#### Personnel

- J. Sweet made a motion seconded by Patterson to offer Tyler Valimont the position of Chief of Police for the Borough of Stoneboro. Effective Monday, August 17, 2015. Tyler will be on a 90 day probationary period. The starting wage will be \$15.00 an hour and if at the end of the 90 days Council agrees that Tyler Valimont's employment should go forward. The hourly rate will increase to \$16.00 with full benefits which include paid vacation starting with 1 week a year for the first 5 years, 2 weeks from 5 to 10 years and 3 weeks after 10 years, pension, medical, and vision insurance. The offer was accepted by Tyler Valimont. The motion carried unanimously.
- Kenton Ewing resigned his position on the Borough of Stoneboro Council. He has moved out of the borough. Council accepted his letter of resignation.

#### Finance

- J. Sweet made a motion seconded by C. Sweet to sell the .357 revolver that Chief DiMaria has used since he began his employment with the Borough of Stoneboro to Chief DiMaria for \$1.00. The motion carried unanimously.
